A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A DEED OF DONATION FOR THE DONATION OF VARIOUS SEARCH AND RESCUE EQUIPMENT TO THE MUNICIPAL GOVERNMENT OF DIVILACAN, ISABELA

WHEREAS, Section 16 of the Local Government Code of 1991 empowers Local Government Units to exercise all powers necessary, appropriate, or incidental for the promotion of the general welfare of their people;

WHEREAS, taking into consideration that the Province of Isabela is susceptible to the effects of various natural disasters and calamities, the Provincial Government of Isabela adopts a disaster risk reduction and management approach that promotes the involvement and participation of all sectors and stakeholders concerned, at all levels, especially the local community;

WHEREAS, last January 24, 2023, an unfortunate aircraft incident occurred when Cessna 206 plane that is bound for Maconacon, Isabela went missing within the Sierra Madre mountain range. Accordingly, the Provincial Government of Isabela made prompt coordinations with the Municipal Government of Divilacan, Isabela (MLGU Divilacan) and other agencies for the conduct of search and retrieval efforts for the plane's passengers;

WHEREAS, the Provincial Government of Isabela provided several tools and equipment to MLGU Divilacan to expedite the location and retrieval of the said plane and its passengers;

WHEREAS, after the successful search and retrieval operations, MLGU Divilacan, thru its Municipal Mayor, requested that the Provincial Government of Isabela donate the following tools and equipment that were utilized during the search and retrieval operations:

- 4 units of Double Head LED 1000L rechargeable search light
- 17 units battery pack for Cignus handheld radios
- 4 units of 30,000 mAh power bank
- 1 unit 32,000 mAh power bank
- 5 units dual ban mobile ham radio antenna
- 2 units 1000W gasoline portable generator set
- 1 unit 14-liter gasoline tank
- 4 units Cignus UV-85 handheld radio with charger

WHEREAS, in recognition of the impactful efforts of MLGU Divilacan in the search and retrieval operations and in line with its policies to strengthen the disaster management capacities of its LGUs, the Provincial Government of Isabela agreed to donate the said tools and equipment;

WHEREAS, the Office of the Provincial Governor submitted a Letter to this August Body requesting that the Provincial Governor be granted with authority to sign a Deed of Donation to effectuate the donation mentioned above;

WHEREAS, after careful review of the submitted proposed Deed of Donation, this August Body determined the same to be just, lawful, and in line with the disaster management policies of the Provincial Government of Isabela. As such, this August Body finds that granting the Provincial Governor the authority to sign on behalf of the Provincial Government of Isabela the proposed Deed of Donation to be beneficial to the Isabeleños:

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Victor G. Dy, duly approved and seconded in a session duly assembled, it was -

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T.
