ALBANO III, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, TO ENTER, SIGN AND EXECUTE A MEMORANDUM OF AGREEMENT WITH THE MUNICIPAL GOVERNMENT OF TUMAUINI, ISABELA THRU NEGOTIATED PROCUREMENT VIA AGENCY-TO-AGENCY PROCUREMENT TO CONDUCT THE SEMINAR WORKSHOP ON PROFILING FOR BIODIVERSITY CONSERVATION AND WILDLIFE LAW ENFORCEMENT

WHEREAS, subject to the approval of the Head of the Procuring Entity, and whenever justified by the conditions in this Act, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement provided in RA 9184;

WHEREAS, one of the alternative methods of procurement is Negotiated Procurement, whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant in case of an Agency-to-Agency Procurement;

WHEREAS, Annex "H", D (5) (b) of the IRR of RA 9184 enumerates the conditions for the adoption of the aforesaid alternative mode of procurement, to wit: (i) The Procuring Entity shall justify the entering into an Agency-to-Agency Agreement with the Servicing Agency is more efficient and economical to the government; (ii) Servicing Agency has the mandate to deliver the goods and services required to be procured or to undertake the infrastructure project or consultancy required by the Procuring Entity; (iii) Servicing agency owns or has access to the necessary;

WHEREAS, the Provincial Government of Isabela (PGI) intends to conduct a Seminar Workshop on Profiling for Biodiversity Conservation and Wildlife Law Enforcement on May 18-19, 2023 and needs to procure 200-cover meals, 200-cover snacks and four (4) rooms at 12 pax per room for the accommodation of participants;

WHEREAS, the PGI decided to utilize the services of the Municipal Government of Tumauini, Isabela as a Procurement Agent to undertake all of the PGI's necessities in the conduct of the aforesaid Seminar;

WHEREAS, for its proper implementation, Section 7.3.3 of the IRR of R.A. No. 9184 requires the execution of a Memorandum of Agreement between the PGI and the Municipal Government of Tumauini, Isabela;

WHEREAS, under Section 465 (b) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Edward S. Isidro duly approved and seconded in a session duly assembled, it was –
