WHEREAS, there can be instances in which both the Provincial Treasurer and the Assistant Provincial Treasurer are unavailable to sign the PGI's financial instruments such as when they are both on travel, leave of absence, or have jointly attended official functions as finance officers. In such cases, delays may occur in the financial transactions of the PGI;

WHEREAS, to prevent such a predicament, the Office of the Provincial Treasurer requested the Provincial Governor to designate Mme. Maria Teresa P. Kanoy, Supervising Administrative Officer, as alternate signatory on the checks or warrants for the PGI's expenditures. Such request has been approved by the Provincial Governor;

WHEREAS, submitted for the review and approval of this August Body is the designation of Mme. Teresa P. Kanoy as alternate signatory on checks or warrants for expenditures of the PGI in case of absence or unavailability of both the Provincial Treasurer and Assistant Provincial Treasurer;

WHEREAS, after careful review, this August Body determined the said designation and grant of authority to be just, lawful, and proper;

WHEREFORE, upon motion of the Honorable Edward S. Isidro, duly approved and seconded in a session duly assembled, it was -
