A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE ISI RESEARCH & TRAINING INSTITUTE, INC. (JSI) FOR THE TUBERCULOSIS IMPLEMENTATION FRAMEWORK AGREEMENT (TIFA)

WHEREAS, last October 2022, the United States Agency for International Development (USAID) released its Global Tuberculosis (TB) Strategy for the years 2023-2030, which aims to achieve USAID's shared vision of a TB-free world and the TB Sustainable Development Goal;

WHEREAS, thru this eight-year strategy, the USAID intends to work with its partners worldwide to reach every person with TB, cure those in need of treatment, and prevent new infections and the progression to active TB disease;

WHEREAS, to achieve the aforesaid goal, scaling-up innovations in detection, care, treatment, and fostering local ownership to sustain TB programs that contributes to pandemic preparedness. Thus, under the Tuberculosis Implementation Framework Agreement (TIFA) of the USAID, a TB Commitment Grant was awarded to the JSI Research & Training Institute, Inc. (JSI) as its recipient;

WHEREAS, under Tuberculosis Grant No. 0012-0549-1015, the Isabela Provincial Health Office (IPHO), was awarded as a subrecipient to the TB Commitment Grant which amounts to TWO HUNDRED SEVEN THOUSAND NINETY FOUR U.S. DOLLARS (\$207,094.00) for the implementation of the TIFA;

WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Memorandum of Agreement between the Provincial Government of Isabela and the JSI Research & Training Institute, Inc.;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after a careful review, this Honorable Body deems the Memorandum of Agreement between the Provincial Government of Isabela and JSI to be just, lawful, and promotive of the health policies of the PGI;

WHEREFORE, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was -
