WHEREAS, with an estimated cost of PHP 30,000,000.00, the Rattan Processing - SSF project aims to provide 200 MSMEs beneficiaries access to modern technologies, equipment and other related services to enhance their competitiveness;

WHEREAS, the PGI recognizes the importance of the SSF project in encouraging innovation and progress of MSMEs in the Province as this will provide access to financing, market information, and other support services with care, vital for local growth and development;

WHEREAS, after a careful review of the Memorandum of Agreement and Deed of Usufruct, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to enter into the said agreements on behalf of the Provincial Government of Isabela;

WHEREAS, Section 465 (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign on its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Dante G. Halaman, duly approved and seconded in a session duly assembled, it was –
