WHEREAS, the Department of Social Welfare and Development is the agency primarily responsible for the protection of the social welfare of rights of Filipinos and for promoting their social development;

WHEREAS, the Provincial Government of Isabela is committed to providing care, protection, and rehabilitation of individuals, families, and communities that have the least in life and need social welfare assistance and social work intervention to restore their normal functioning and enable them to participate in community affairs;

WHEREAS, the Department of Social Welfare and Development, pursuant to Executive Order No. 221, series of 2003, and Executive Order No. 137, series of 2021, implements crisis intervention, through the Assistance to Individuals and Families in Crisis Situation (AICS) Program;

WHEREAS, the Department of Social Welfare and Development, through its Field Office in Region 02, and the Provincial Government of Isabela seek to strengthen their coordination in implementing the AICS Program in Isabela;

WHEREAS, submitted for the review and approval of this August Body is a letter from the Office of the Governor requesting that the Provincial Governor be granted with authority to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development – Regional Field Office No. 02 (DSWD – RO2) providing the guidelines for the implementation of the AICS Program in the Province of Isabela;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Margarette U. Chin, duly approved and seconded in a session duly assembled, it was -

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T.
