WHEREAS, it is the policy of the State to establish one police force which shall be national in character, to be administered and controlled by a National Police Commission;

WHEREAS, under the Republic Act No. 6975, otherwise known as the "DILG Act of 1990" as amended by Republic Act No. 8551, or the "Philippine National Police Reform and Reorganization Act of 1998", the Philippine National Police (PNP) and the

A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE NATIONAL POLICE COMMISSION (NAPOLCOM) FOR THE CONDUCT OF PNP ENTRANCE AND PROMOTIONAL EXAMINATIONS IN CAUAYAN CITY, ISABELA

National Police Commission (NAPOLCOM) was created which mandates the latter to exercise administrative control and operational supervision over the former;

WHEREAS, pursuant to Section 32 of R.A. No. 6975, as amended by Section 21 of R.A. No. 8551, the NAPOLCOM is assigned to conduct PNP Entrance and Promotional Examinations for civilians desiring to enter the police service and for promotion of uniformed personnel of the PNP;

WHEREAS, due to the budgetary constraints of NAPOLCOM and the growing number of aspiring NAPOLCOM examinees, there is a shortage in the number of available slots, which is detrimental to those Isabeleños seeking to take part in the aforesaid examination:

WHEREAS, to fully accommodate all of the aspiring Isabeleños, the Provincial Government of Isabela (PGI), thru the Provincial Governor, Hon. Rodolfo T. Albano III, has expressed its interest to provide assistance to the NAPOLCOM and its constituents;

WHEREAS, the Office of the Provincial Governor, thru the Office of the Provincial Administrator, submitted a Letter before this Honorable Body requesting that the Provincial Governor be granted with authority to sign a Memorandum of Agreement on behalf of the PGI;

WHEREAS, Section 465(b) (1) (vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Honorable Body determined that the proposed Memorandum of Agreement to be executed by the PGI and the NAPOLCOM, will be beneficial and advantageous to Isabeleños;

WHEREFORE, upon motion of Honorable Edward Isidro, duly approved and seconded in a session duly assembled, it was -

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE NATIONAL POLICE COMMISSION (NAPOLCOM) FOR THE CONDUCT OF PNP ENTRANCE AND PROMOTIONAL EXAMINATIONS IN CAUAYAN CITY, ISABELA.
