WHEREAS, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to "review all ordinances approved by the sangguniang of component cities and municipalities" and to "determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor":

WHEREAS, presented before this Honorable Body is Municipal Ordinance No. 2022-011 enacted by the Sangguniang Bayan of Echague, Isabela titled "AN ORDINANCE APPROVING THE REZONING OF A PARCEL OF LAND FROM RESIDENTIAL LOT TO COMMERCIAL LOT CONTAINING AN AREA OF SIX HUNDRED SIXTY FOUR (664) SQ. MTS. MORE OR LESS SITUATED IN THE BARRIO OF ANNAFUNAN, MUNICIPALITY OF ECHAGUE, PROVINCE OF ISABELA COVERED AND EMBRACED BY TCT NO. (T-259576)

A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2022-011 OF THE SANGGUNIANG BAYAN OF ECHAGUE, ISABELA AS INTRA VIRES

SC-79781 OF THE REGISTRY OF DEEDS FOR THE PROVINCE OF ISABELA REGISTERED IN THE NAME OF FERNANDO RANOT, SR. MARRIED TO ANOFRA BIAUG OF ANNAFUNAN, ECHAGUE, ISABELA";

WHEREAS, as provided in the Ordinance, the Sangguniang Bayan of Echague, Isabela changed the category of the aforementioned lot from Residential to Commercial;

WHEREAS, Republic Act. No. 7160, otherwise known as the Local Government Code of 1991, grants the Local Government Units the power to rezone and change the category of lands to residential, commercial, industrial, or other purposes subject to the determination that such land will have more economic value if rezoned;

WHEREAS, this Honorable Body recognizes that local government units are more abreast with regard to the needs of their citizens and the conditions within their jurisdiction and thus have the necessary competence in formulating the appropriate strategies and implementing the essential measures for the advancement of their people and territory;

WHEREAS, after careful review, subject to pertinent regulations and issuances of the Housing and Land Use Regulatory Board and other relevant laws and rules, this Honorable Body finds that the rezoning of the aforementioned lot from Residential to Commercial, made pursuant to Ordinance No. 2022-011 of the Sangguniang Bayan of Echague, Isabela to be a valid exercise of their legislative power and is within the authority of the Municipal Local Government Unit of Echague, Isabela as prescribed by law;

WHEREFORE, upon motion of Honorable Mary Grace D. Arreola, duly approved and seconded in a session duly assembled, it was —

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2022-011 OF THE SANGGUNIANG BAYAN OF ECHAGUE, ISABELA AS INTRA VIRES.
