ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES-REGION 02 FOR THE IMPLEMENTATION OF THE TREE CUTTING REPLACEMENT PROGRAM OF DINAPIGUE MINING CORPORATION (DMC)

WHEREAS, Executive Order No. 23, Series of 2011, otherwise known as the "National Greening Program" (NGP) was implemented as a government priority program that aims to reduce poverty, promote food security, environmental stability, biodiversity conservation, and enhancement of the climate change mitigation and adaptation;

WHEREAS, with the threat of climate change, forests and forestry remain as the carbon sink that could sustain the industrial development and economic growth of the country. Thus, in order to accelerate the rehabilitation and reforestation of unproductive, denuded, and degraded areas, the government encourages the involvement of the private sector with a view towards enabling private companies to achieve carbon neutrality;

WHEREAS, the Dinapigue Mining Corporation (DMC) is a mining company that signifies its intention to the Department of Environment and Natural Resources (DENR) to take part in the NGP, more specifically in providing financial assistance to NGP projects and to form part of the terms and conditions of its cutting permit issued by DENR for the replacement of each trees affected its operation;

WHEREAS, the Provincial Government of Isabela (PGI) manifests its objective of participating in the National Greening Program (NGP) under the Tree Cutting Replacement Program of Dinapigue Mining Corporation (DMC);

WHEREAS, to attain the endeavor of the PGI, a Memorandum of Agreement (MOA) must be executed between the DENR-RO2 and the Provincial Government of Isabela (PGI);

WHEREAS, the Office of the Provincial Governor submitted a Letter to this Honorable Body requesting that the Provincial Governor be granted with authority to sign a MOA on behalf of the PGI for the implementation of the Tree Cutting Replacement Program of Dinapigue Mining Corporation (DMC);

WHEREAS, Section 465(b) (1) (vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Honorable Body determined that the proposed Memorandum of Agreement to be executed by the PGI and DENR-RO2 will be beneficial and advantageous to the Province;
