ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT FOR THE IMPLEMENTATION OF THE "RISK RESILIENCY PROGRAM-CLIMATE CHANGE ADAPTATION AND MITIGATION DISASTER RISK REDUCTION" (RRP-CCAM DRR) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE 02 AND THE COMPONENT CITIES AND MUNICIPALITIES IN THE PROVINCE OF ISABELA

WHEREAS, the Risk Resiliency Program-Climate Change Adaptation and Mitigation Disaster Risk Reduction (RRP-CCAM DRR) is a national program which aims to strengthen the resiliency of the natural systems and the urban built environment, as well as to reinforce the adaptive capacities of vulnerable groups and communities in the country;

WHEREAS, the program utilizes the Cash-for-Work (CFW) modality to implement different projects and activities related to Environmental Protection, Support to Construction or Repair of Small-Scale Community Infrastructure, and Livelihood Projects;

WHEREAS, under such program, the DSWD will provide labor cost for projects and activities relative to the adaptation and mitigation of the impacts of climate change and reduction of disaster risks thru Cash-for-Work modality. Moreover, the target beneficiaries will work for ten (10) days and receive cash payment in exchange for the work rendered;

WHEREAS, recognizing the vulnerability of the Philippine archipelago and its local communities to potential dangerous consequences of climate change, the Provincial Government of Isabela (PGI) intends to participate in this Tripartite Memorandum of Agreement (MOA);

WHEREAS, recognizing the importance of partnership in the implementation of a Risk Resiliency Program, a Memorandum of Agreement (MOA) must be executed between Provincial Government of Isabela (PGI), DSWD Field Office 02 and the Component Cities and Municipalities of the Province of Isabela;

WHEREAS, the Office of the Provincial Governor submitted a Letter to this Honorable Body requesting that the Provincial Governor be granted with authority to sign a MOA on behalf of the PGI for the implementation of the partnership program, "Risk Resiliency Program Climate Change Adaptation and Mitigation Disaster Risk Reduction" (RRP-CCAM DRR);

WHEREAS, Section 465(b) (1) (vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Honorable Body determined that the proposed Memorandum of Agreement to be executed by the PGI, DSWD FO2, and the Component Cities and Municipalities of the Province of Isabela, will be beneficial and advantageous to the Province;

WHEREFORE, upon motion of Honorable Marco Paolo A. Meris, duly approved and seconded in a session duly assembled, it was –
