(P8,696,000.00) respectively, covering various expenditures for the operation of the Local Government of the City of Cauayan, Isabela for Fiscal Year 2023, and appropriating the necessary funds for the purpose, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements, general limitations and other provisions set forth under Republic Act No. 7160:

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2022-495 (2023 Annual Budget) and 2022-496 (2023 Annual Budget for the Operation of City Economic Enterprise) of the City of Cauayan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160 and subject further to the following conditions:

- The lump sum appropriation for SSL V Fourth Tranche Compensation Adjustment in the amount of Fifteen Million Pesos (P15,000,000.00) must be distributed in the Plantilla in accordance with the guidelines of DBM Local Budget Circular No. 149, dated January 10, 2023, on the Implementation of the Fourth Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to Republic Act (RA) No. 11466;
- 2. This is to reiterate our review action on your 2021 and 2022 Annual Budget that the grant of Clothing Allowance in the amount of One Million Eight Hundred Fourteen Thousand Pesos (P1,814,000.00) under the Mayor's office shall be in accordance with DBM Budget Circular No. 2018-1 dated March 8, 2018, on the Rules and Regulations on the Grant of Uniform/Clothing Allowance (U/CA) to Civilian Government Personnel;
- 3. Reiterating our review action on your 2021 and 2022 Annual Budget that the grant of **Cash Gift** in the amount of Three Million Seven Hundred Forty Five Thousand Pesos (P3,745,000.00) under the Mayor's Office shall be in accordance with DBM Budget Circular No. 2016-4 dated April 28, 2016, on the Updated Rules and Regulations on the Grant of the Year-end Bonus and Cash Gift for FY 2016 and Years Thereafter;

Reiterating that the position of Assistant City Health Officer with SG-23/6 at the City Health Office is not within the list of position titles found in DBM LBC No. 137 dated July 13, 2021, the Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU), CY 2021 Edition. Since the subject position does not have legal basis to back up its existence, it is hereby recommended to be downgraded to a position identified under the said IOS and corrections shall be effected without diminution in salary of the concerned personnel. However, subsequent salary increase shall be applied only on the correct classified position;
- 7. RESOLVED FURTHERMORE, to inform the City of Cauayan, Isabela that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
