ALBANO III, TO ENTER INTO TERMS OF PARTNERSHIP WITH THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA FOR THE IMPLEMENTATION AND MANAGEMENT OF THE ANNUAL OPERATION PLAN FOR FISCAL YEAR 2023

WHEREAS, to support the implementation of UHC Act, the National Government developed Fourmula One Plus for Health, a comprehensive financing strategy aimed to ensure the access and delivery of quality healthcare services to all Filipinos;

WHEREAS, the Local Government Code of 1991, and as reiterated in Executive Order No. 138, series of 2021, mandated that the responsibility of delivering basic health services and facilities to the people be devolved to Local Government Units (LGUs);

WHEREAS, in compliance with the mandate of the UHC Act and to facilitate the process of devolving to LGUs the responsibility of delivering basic health services and facilities to the people, the Department of Health (DOH) commits to extending necessary and appropriate assistance to LGUs to improve the functionality and effectiveness of province-wide and city-wide health systems;

WHEREAS, The PGI in coordination with the DOH developed its Local Investment Plan for Health (LIPH) and 2023 Annual Operation Plan (AOP) which identifies priority health programs and services that the PGI intends to invest based on the health needs of the local population, consistent with the policies provided under the UHC Act and Fourmula One Plus for Health;

WHEREAS, as a display of their steadfast commitment, the PGI and the DOH endeavour to enter into Terms of Partnership to lay down their duties and responsibilities on the implementation of the UHC Act and Fourmula One Plus for Health as established in the LIPH and the 2023 AOP;

WHEREAS, submitted for the review and approval of this August Body is the proposed Terms of Partnership between the PGI and the DOH providing their respective duties and responsibilities in implementing the LIPH and 2023 AOP;

WHEREAS, under Section 465(b)(vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Terms of Partnership on behalf of the Provincial Government of Isabela;

WHEREAS, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
