WHEREAS, Republic Act No. 11223, otherwise known as the "Universal Health Care" (UHC) Act was enacted to enable a Province-Wide Health System-an integrated and coordinated approach to healthcare service delivery, which allows LGUs within a province to pool their resources, expertise, and facilities to ensure seamless access to healthcare services for all residents;

WHEREAS, the Provincial Government of Isabela (PGI) recognizes the importance of implementing Province-Wide Health System under the Universal Health Care Law, as cooperation among the component cities and municipalities of the Province of Isabela is essential for the realization of the objectives of the Universal Health Care Act;

WHEREAS, consistent with the policies of the Universal Health Care Act, the PGI and its component cities and municipalities have expressed their desire to enter into an Inter-Local Government Unit (Inter-LGU) Memorandum of Agreement to prevent duplication of efforts, improve efficiency, and optimize the utilization of limited resources in the health sector;

WHEREAS, under Section 465(b)(vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, submitted for the review and approval of this August Body is the proposed Inter-LGU Memorandum of Agreement between the PGI and its component cities and municipalities providing their respective duties and responsibilities in the implementation of Province-Wide Health System;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Honorable Governor the necessary authority to sign the Inter-LGU Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, A MEMORANDUM AGREEMENT WITH ITS COMPONENT CITIES AND MUNICIPALITIES FOR THE INTERLOCAL GOVERNMENT UNIT COOPERATION IN THE IMPLEMENTATION OF PROVINCE WIDE HEALTH SYSTEMS UNDER THE UNIVERSAL HEALTH CARE ACT.
