WHEREAS, ISU seeks to collaborate with the PGI through the Provincial Veterinary Office (PVO) in order to forge a partnership that establishes the PVO as a designated training venue for the implementation of a Clinical Internship Program;

WHEREAS, the Clinical Internship Program aims to augment the practical training and experiential learning of veterinary medicine students that will equip them with hands-on experience in a real-world clinical setting, enabling them to develop their skills, knowledge, and competence under the supervision of qualified professionals;

WHEREAS, the PGI recognizes the importance of promoting education and providing opportunities for practical training to students pursuing degrees in veterinary medicine, hence, desirous to collaborate with the ISU for the implementation of the Clinical Internship Program;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of the Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was -
