WHEREAS, DSAC Ilagan seeks the support of the Provincial Government of Isabela (PGI) for the proper implementation of the program and the provision of training modules, technical assistance, and capacity development to identified communities and stakeholders;

WHEREAS, under Section 465 (b) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Understanding on behalf of the Provincial Government of Isabela;
