WHEREAS, the Provincial Government of Isabela along with the Local Government Units, National Agencies, and other stakeholders recognizes the importance of promoting agricultural development and enhancing the knowledge and skills of local corn farmers, as these are crucial for ensuring food security, driving economic growth, building crop resilience, and fostering overall agricultural sustainability;

WHEREAS, the Provincial Government of Isabela in collaboration with the Local Government Unit of the City of Ilagan, Enviro Scope Synergy Inc., Asosasyon ng mga AMA Siyudad ng Ilagan, the Department of Agriculture – Regional Field Office No. 02, the Philippine Center for Post-Harvest Development and Mechanization, the Philippine Crop Insurance Corporation Regional Office 02, and the DA Agricultural Training Institute-Regional Training Center 02, have expressed their interest to establish the Isabela Provincial Corn Derby Demonstration, and to conduct Season-long On-site Farmers' Field School;

WHEREAS, the Isabela Provincial Corn Derby Demonstration aims to showcase innovative corn farming techniques, best practices, and the use of modern technologies, thereby improving the productivity and efficiency of corn farming in Isabela;

WHEREAS, the Season-long On-site Farmers' Field School will provide practical training and hands-on learning opportunities for local farmers, enabling them to acquire knowledge and skills in the application of sustainable agricultural practices, crop management, and post-harvest technologies;

WHEREAS, to realize the objectives of the Isabela Provincial Corn Derby Demonstration and the conduct of the Season-long On-site Farmers' Field School, a Memorandum of Agreement needs to be established to outline the roles, responsibilities, and commitments of all stakeholders involved in the implementation thereof;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, upon careful review, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;
