WHEREAS, it is the policy of the Provincial Government of Isabela (PGI) to support and foster the development of the agriculture sector towards increased investments, infrastructure development, and improved access to markets and services to sustain the overall development and empowerment of rural communities;

WHEREAS, the success and effective implementation of this I-REAP subproject requires the support and collaboration of San Agustin Dairy Cooperative;

WHEREAS, consistent with the Enterprise Development Operations Manual and Procurement Guidelines of the DA-PRDP, the PGI procured articles to facilitate the implementation of the I-REAP subproject, particularly described as follows:

- One(1) Unit Water Softener/Purifier, (1set, 3 stages);
- 2. One(1) Unit Soft Ice Cream Maker with Freezer No. of Flavors: 2+1 mixed. Freezing, Cylinder: 1.8Lx2, Mix Hopper: 6Lx2 Weight 135kg;
- 3. One(1) Set milking machine for Com/Buffalo, Electric Type Spec: 1-unit vacuum 50kpa; 1-unit motor 75kw, 220v, 60hz single phase, 1pc vacuum tank, 2 stainless steel milk bucket 25L; 1 set cleaning brushes, 1 unit magnetic;
- 4. One(1) Unit Standby generator set, 30 kva capacity, 60hz, 220-240 volts, diesel, 3 phase, soundproof;
- 5. One(1) Unit Refrigerated Van;
- 6. One(1) Unit Cold Storage Facilities;
- 7. Two(2) Units Blender;
- 8. One(1) Unit Mechanical Weighing Scale;
- 9. One(1) Unit Candy Maker Stainless;
- 10. Three(3) Units Upright Chiller;
- 11. One(1) Unit Yogurt Incubator;
- 12. Eight(8) Units Stainless Milk Tan; and
- 13. Sinaoangan Sur Milking Barn, San Agustin, Isabela

WHEREAS, pursuant to Article V, Section 5.01(h) of the Enterprise Investment Agreement (EIA), the PGI through the Provincial Project Management and Implementing Unit (PPMIU) shall facilitate the turn-over of the prescribed articles through a Deed of Donation and Certificate of Turn-Over;

WHEREAS, submitted to this August Body is the proposed Deed of Donation executed between the PGI and San Agustin Dairy Cooperative;

WHEREAS, after careful review of such deed, this August Body determined the same to be just, lawful, and promotive of the welfare of Isabeleños;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, this August Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Deed of Donation on behalf of the Provincial Government of Isabela;

WHEREFORE, upon motion of the Honorable Adrian Philip S. Baysac, duly approved and seconded by all members in a session duly assembled, it was –
