WHEREAS, the collaboration between the PGI, the University of the Philippines, and Eagles CVR8 will contribute to the enhancement of healthcare delivery and the promotion of public welfare especially in the marginalized and undeserved areas in the Province of Isabela;

WHEREAS, submitted for the review and approval of this August Body is the draft Memorandum of Agreement to be executed by the PGI, the University of the Philippines, and Eagles CVR8, establishing the guidelines for the conduct of the surgical mission;
