WHEREAS, the Municipal Government of Divilacan aspires to establish an ambulance services partnership and referral system to sustain an effective Emergency Medical Response:

WHEREAS, the Provincial Government of Isabela (PGI) shares the same goal of providing efficient healthcare services and ensuring the availability of Emergency Medical Response services to its constituents;

WHEREAS, both the PGI and the Municipal Government of Divilacan acknowledges the mutual benefits of collaborating on ambulance services partnerships and referral mechanisms;

WHEREAS, submitted for the review and approval of this August Body is the draft Memorandum of Agreement to be executed by the PGI and Municipal Government of Divilacan which seeks to establish a partnership and patient referral system for the patients of Divilacan Rural Health Unit;

WHEREAS, after a careful review of the Memorandum of Agreement this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, Section 465 (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign on its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was —
