WHEREAS, the Provincial Government of Isabela (PGI) shares the commitment to ensuring that its constituents have access to comprehensive and accurate laboratory and diagnostic services;

WHEREAS, both the PGI and the Municipal Government of Divilacan acknowledges the mutual benefits of laboratory and diagnostic services partnership to sustain the quality healthcare delivery and efficient patient referrals;

WHEREAS, submitted for the review and approval of this August Body is the draft Memorandum of Agreement to be executed by the PGI and the Municipal Government of Divilacan which seeks to establish a partnership and patient referral system for the patients of Divilacan Rural Health Unit;

WHEREAS, after a careful review of the Memorandum of Agreement this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, Section 465 (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign on its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;
