WHEREAS, the Adopt-a-School Program serves as a platform for collaboration between local government units and educational institutions to support initiatives that promote the welfare of students;

WHEREAS, the School Milk Feeding Project has been identified as a valuable program that significantly contributes to the nutritional needs of students, thereby enhancing their development and learning capabilities;

WHEREAS, the PGI shares the same goal of providing services aimed at bridging nutritional gaps to ensure that all students have access to vital nutrients necessary for their growth and learning development.;

WHEREAS, Section 465 (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign on its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, submitted for the review of this August Body is the draft Memorandum of Agreement to be executed by the PGI and SDO Isabela for the implementation of School Milk Feeding Project;

WHEREAS, after a careful review of the Memorandum of Agreement this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREFORE, upon motion of the Honorable Mary Grace D. Arreola, duly approved and seconded in a session duly assembled, it was –
