WHEREAS, the Department of Agriculture-Regional Field Office No. 02 (DA-RFO 02) is primarily concerned in improving farm productivity and income generating work opportunities for farmers, fisherfolk and other rural workers, and encourage people's participation in agricultural development through sectoral representation in agricultural policy-making bodies;

WHEREAS, the DA-RFO 02, in collaboration with LGUs and selected stakeholders, shall establish a Provincial Rice Techno Forum (PRTF) to showcase the different farm mechanization and post-harvest services, demonstrate various Package of Technology (POT) on hybrid rice production, and train farmer-cooperators on the different cultural practices to capacitate them to adopt the technology;

WHEREAS, the Provincial Rice Technology Forum (PRTF) is a compact area of Twenty Six (26) hectares with Nineteen (19) farmer-cooperators to be established during the Wet Season 2023;

WHEREAS, for the proper implementation of the program, it requires the execution of a Memorandum of Agreement between the PGI and several National agencies, LGUs, and stakeholders;

WHEREAS, under Section 465 (b) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was –
