WHEREAS, Section 13 (a) of Republic Act No. 11203, otherwise known as the "Rice Tarrification Act" mandated the Philippine Center for Postharvest Development and Mechanization (PhilMech) to spearhead and implement the Mechanization Component of the Rice Component of the Rice Competitiveness Enhancement Fund (RCEF);

WHEREAS, the RCEF-Mechanization Component provides for the establishment of a Farm Machinery and Equipment to make accessible the appropriate rice production and postharvest machinery and equipment. Further, this will enable the small farmers to improve their productivity through appropriate and efficient mechanization technologies;

WHEREAS, the Provincial Government of Isabela (PGI) requested PhilMech for an additional 12-Tonner Capacity Recirculating Mechanical Dryer to avail the Rice Processing System 2 (RPS 2) under the RCEF Mechanization Component;

WHEREAS, this additional equipment will benefit the rice farmers within and nearby the Municipality of Echague, Isabela;

WHEREAS, for the proper implementation and enjoyment of benefits of the program, it requires the execution of a Memorandum of Agreement between the PGI and the Philippine Center for Postharvest Development and Mechanization;

WHEREAS, under Section 465 (b) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

**WHEREAS,** premises considered, upon motion of Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was —
