San Mariano, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2022-1292 of the Municipality of San Mariano, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. That the utilization of the amount of Two Million Seven Hundred Seventy Three Thousand Pesos (P2,773,000.00) must be governed by Sec. 15 RA 9344, which states:

"One percent (1%) of the Internal Revenue Allotment of barangays, municipalities and cities shall be allocated for the strengthening and implementation of the programs, projects and activities of the LCPC provided, such allocation shall be disbursed in accordance with the AWFP endorsed by the LCPC to the local Sanggunian."

2. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations. Further, the acquisition of Motor Vehicle in the amount of Two Million One Hundred Fifty Thousand Pesos (P2,150,000.00) shall be subject to the provisions of Budget Circular No. 2019-3 dated May 16, 2019 and Administrative Order No. 14 dated December 10, 2019;

RESOLVED FURTHER, to require the Municipality of San Mariano, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of San Mariano, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
