ALBANO III, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, TO ENTER, SIGN AND EXECUTE A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE-PHILIPPINE CENTER FOR POSTHARVEST DEVELOPMENT AND MECHANIZATION FOR THE PROCUREMENT OF ADDITIONAL THREE UNITS OF RECIRCULATING DRYERS AND RICE PROCESSING SYSTEM III

WHEREAS, the RCEF-Mechanization Component provides for the establishment of a Farm Machinery and Equipment to make accessible the appropriate rice production and postharvest machinery and equipment. Further, this will enable the small farmers to improve their productivity through appropriate and efficient mechanization technologies;

WHEREAS, the Provincial Government of Isabela (PGI) has the competence to promote mechanized farming practices, empower the farmers, and promote the proper adoption of production and its processing methods.

WHEREAS, as the beneficiary of the Program, the PGI is among the stakeholders of the rice industry who qualifies and passed the accreditation requirements to receive projects and is willing to collaborate in its implementation;

WHEREAS, these additional equipments and processing system will benefit the rice farmers within and nearby the Municipality of Echague, Isabela;

WHEREAS, for the proper implementation and enjoyment of benefits of the program, it requires the execution of a Memorandum of Agreement between the PGI and the Philippine Center for Postharvest Development and Mechanization;

WHEREAS, under Section 465 (b) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was -
