WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Memorandum of Agreement between the PCSO and the PGI;

WHEREAS, after careful review, this Honorable Body deems the Memorandum of Agreement between the PGI and the PCSO to be just, lawful, and promotive of the healthcare policies of the PGI;

WHEREAS, Section 465 (b)(1)(vi) of R. A. No. 7160 empowers the Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

**WHEREFORE**, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
