A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 02 S. 2023 (SUPPLEMENTAL BUDGET NO. 02 FY 2023) IN THE AMOUNT OF ONE HUNDRED TWO MILLION THREE HUNDRED SEVENTY FOUR THOUSAND TWO HUNDRED SIXTY THREE PESOS (P102,374,263.00) OF THE MUNICIPALITY OF MALLIG, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

Year 2020, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

**NOW THEREFORE**, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 02 S. 2023 of the Municipality of Mallig, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- 1. The utilization of the project to be funded from the Local Government share in the Burley and Native Tobacco Excise Tax for the Fiscal Year 2020 amounting to One Hundred Two Million Three Hundred Seventy Four Thousand Two Hundred Sixty Three Pesos (P102,374,263.00), shall adhere with the provisions of LBM No. 86, dated December 14, 2022, the Guidelines on the release and utilization of the shares of Local Government Units (LGUs) from the FY 2020 collections of Excise Taxes on Locally Manufactured Virginia-type Cigarettes under Republic Act No. 7171, and Burley and Native Tobacco Excise Taxes pursuant to RA No. 8240, as amended by RA No. 10351, and as further amended by RA No. 11346, chargeable against the Allocations to Local Government Units (ALGU) under the FY 2022 General Appropriations Act (GAA), RA No. 11639;
- 2. The project *Development of Mallig Eco Park (Construction of Function Hall and Refreshment Area)* is not included in the menu/projects to be funded from the LGU share from Burley and Native Tobacco Excise Tax (LBM No. 86). However, said project shall be replaced or substituted with another project that is compliant with **Item No. 2.3.1 of LBM No. 86**;
- 3. That the appropriation for the following accounts should be properly classified to specific Object of Expenditures and Account Code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:
