THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2022-077 of the Municipality of Jones, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- The appropriation for the grant of Collective Negotiation Agreement (CNA) in the amount of Two Million Seven Hundred Sixty Thousand Pesos (P2,760,000.00) shall be in accordance with DBM Budget Circular No. 2022-3, dated October 19, 2022, on the Guidelines on the Grant of the Collective Negotiation Agreement (CNA) Incentive for FY 2022;
- The appropriation for the grant of Service Recognition Incentive (SRI) in the amount of Four Million Six Hundred Thousand Pesos (P4,600,000.00) shall be in accordance with DBM Budget Circular No. 2022-4, dated December 20, 2022, on the Guidelines on the Grant of Service Recognition Incentive to Government Employees for Fiscal Year (FY) 2022;

RESOLVED FURTHER, to require the Municipality of Jones, Isabela to comply with the herein review findings and/or conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Jones, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
