WHEREAS, recognizing the shared objectives, the PGI and DOH-CVCHD aspires to implement the Medical Assistance to Indigent Patients (MAIP) Program which aims to provide financial and medical support to underprivileged individuals who lack the means to afford essential healthcare services:

WHEREAS, the PGI in collaboration with the DOH-CVCHD through a Memorandum of Agreement, the PGI can leverage resources, expertise, and networks to effectively deliver medical assistance to indigent patients;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was -
