WHEREAS, the Provincial Government of Isabela recognizes the importance of ensuring sound fiscal management in the promotion of the government's financial stability and in ensuring the uninterrupted delivery of effective public services;

WHEREAS, consistent with its mandate to deliver efficient, fast, and quality services to its people, the Provincial Government of Isabela entered into a loan agreement amounting to P2.98 with the Development Bank of the Philippines in 2014 to fund various projects;

A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR RODOLFO T. ALBANO III TO EXECUTE AND SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) A LETTER-AGREEMENT WITH THE DEVELOPMENT BANK OF THE PHILIPPINES TO EFFECTUATE THE RE-AMORTIZATION OF THE PGI'S APRIL 08, 2014 LOAN, AS AMENDED

WHEREAS, the Provincial Government of Isabela and the Development Bank of the Philippines entered into Letter Amendments covering such loan agreement on 20 March 2018, 5 September 2019, 10 July 2020, 10 May 2022, and 12 August 2022;

WHEREAS, the Provincial Government of Isabela requested the Development Bank of the Philippines for the re-amortization of the said loan, without change in its maturity, to the effect that the latter will only collect 10% of the supposed principal amortization for the years 2024 to 2027 and the balance to be distributed on the remaining term of each facility, and the extension of the fixed interest rate of 4.5% per annum, inclusive of gross receipt tax, payable monthly, for three (3) years from September 3, 2023 to September 3, 2026;

WHEREAS, the Development Bank of the Philippines has approved such request of the Provincial Government of Isabela;

WHEREAS, the Provincial Government of Isabela and the Development Bank of the Philippines must execute and sign a letter-agreement to effectuate their recent agreement. For such purpose, the Office of the Governor sent a letter to this August Body requesting that the Governor be granted with authority to execute and sign the said letter-agreement on behalf of the Provincial Government of Isabela;

WHEREAS, after careful review, this August Body determined the said letteragreement to be just and lawful and consistent with the sound fiscal management policies of the Provincial Government of Isabela;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Edward S. Isidro, duly approved and seconded in a session duly assembled, it was -
