WHEREAS, in line with such commitment, the Provincial Government of Isabela coordinates and collaborates with various institutions, both public and private, for the continuous enhancement of its capacity to provide effective and essential government services to its people;

WHEREAS, recognizing the resolve of His Excellency, President Ferdinand Romualdez Marcos Jr., in addressing and resolving poverty in the country, the Provincial Government of Isabela endeavors to partner with the Office of the President for the improvement and expansion of the government services that the provincial government provides;

WHEREAS, the Office of the President favorably considered such endeavor of the Provincial Government of Isabela and approved the grant of Php10,000,000.00, under its Socio-Civic Project Funds, to the latter;

WHEREAS, the receipt and utilization of the grant necessitates the execution of a Memorandum of Agreement between the Provincial Government of Isabela and the Office of the President;

WHEREAS, presented for the review and consideration of this August Body is the proposed Memorandum of Agreement between the Provincial Government of Isabela and the Office of the President for the latter's grant of Php10,000,000.00, under its Socio-Civic Project Funds, to the provincial government;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after careful review, this August Body determined the said proposed Memorandum of Agreement between the Provincial Government of Isabela and the Office of the President to be just and lawful and that granting the Honorable Governor the authority to sign such document on behalf of the Provincial Government of Isabela to be beneficial to the Isabeleños;

WHEREAS, the Provincial Government of Isabela extends its deepest gratitude to His Excellency President Ferdinand Romualdez Marcos Jr. for extending helpful assistance to the Province of Isabela which will contribute to the improvement of the lives of many Isabeleños;
