WHEREAS, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to "review all ordinances approved by the sanggunian of component cities and municipalities" and to "determine whether these are within the scope of the prescribed powers of the sanggunian";

WHEREAS, presented before this Honorable Body is Municipal Ordinance No. 2021-11 of the Municipal Local Government Unit of Santa Maria, Isabela (MLGU Santa Maria) titled "AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE LOCAL GOVERNMENT OF SAN AGUSTIN, ISABELA IN THE AMOUNT OF ONE HUNDRED MILLION PESOS (PHP 100,000,000.00) TO FINANCE PRIORITY PROJECTS IN THIS MUNICIPALITY";

WHEREAS, as stated in the Ordinance, MLGU San Agustin will enter into a Loan Agreement with the Development Bank of the Philippines for the amount of One Hundred Million Pesos (Php100,000,000.00) which shall be utilized to finance the implementation of various projects in San Agustin, Isabela;

WHEREAS, Section 297(a) of the Local Government Code allows local government units to contract loans, credits, and other forms of indebtedness with any government or domestic private bank and other lending institutions to finance the construction, installation, improvement, expansion, operation, or maintenance of public facilities, infrastructure facilities and the implementation of other capital investment projects, subject to such terms and conditions as may be agreed upon by the local government unit and the lender;

WHEREAS, this Honorable Body recognizes that local government units possess direct information concerning the needs of their citizens and the conditions within their jurisdiction and thus have the appropriate standing and capacity to identify the programs, projects, and activities that will further the welfare of their people;

WHEREAS, after careful review and with due consideration to the recommendation of the Provincial Budget Office interposing no objection and stating no adverse finding to the Ordinance No. 2023-16 of the MLGU San Agustin, Isabela, this Honorable Body find that the said ordinance is a valid exercise of the legislative powers of their sanggunian and within the authority of MLGU San Agustin, Isabela as prescribed by law subject to compliance with the budgetary limitations for debt servicing as provided in Section 324 of the Local Government Code;

WHEREFORE, upon motion of the Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2023-16 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF SAN AGUSTIN, ISABELA AS INTRA VIRES.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable CESAR A. MONDALA**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of San Agustin, Isabela through the **Honorable OLIVER D. MICU**, Municipal Vice-Mayor.
