WHEREAS, the Investment and Incentives Board of Isabela (IIBI) is vested with the responsibility of driving economic development, attracting investments, and supporting businesses within the Province of Isabela;

WHEREAS, IIBI has diligently reviewed and assessed the application of SMFI for fiscal incentives in connection with their feed mill-plant in Echague, Isabela, and has recommended the grant of fiscal incentive pursuant to the Provincial Investment and Incentive Code in favour of the San Miguel Foods Incorporated by way of exemption from the payment of the Provincial share of 35% of the basic real property tax due from and over the real properties in its Feed-Mill Plant located in Brgy. Soyung, Echague, Isabela and which real properties are enumerated in Appendix A hereof, for its fiscal years 2024 and 2025 only;

WHEREAS, the IIBI, through Resolution No. 1 Series of 2023, has submitted its recommendation for approval and adoption of this Honorable Body;

WHEREAS, following a thorough examination, it was concluded that the grant of fiscal incentives to SMFI aligns with the economic development objectives of the PGI, and hereby expresses its approval to the Resolution No. 1, series of 2023, of the IIBI;
