WHEREAS, Ordinance No. 2022-1296, an Ordinance authorizing the Annual General Fund Budget and the operation of Economic Enterprise of San Mariano, Isabela in the amount of FIVE HUNDRED THIRTY SIX MILLION SIXTY SEVEN THOUSAND SIX HUNDRED TWENTY SEVEN PESOS (P536,067,627.00) and SIX MILLION PESOS (P6,000,000.00) respectively, covering various expenditures for the operation of the Municipal Government of San Mariano, Isabela for Fiscal Year 2023 and appropriating the necessary funds for the purpose pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

However, when the position becomes vacant it shall be downgraded to conform to the provisions of Local Budget Circular No. 53 dated September 1, 1993.
- 3. Reiterating our review action on your 2022 Annual Budget that the corrections of the disallowed position of Board Secretary IV in your 2020, 2021 and 2022 Annual Budget under the Secretary to the Sangguniang Bayan Office should be:

- 5. The Office of the Municipal Tourism Officer must be headed by a Department Head pursuant to the Civil Service Commission Memorandum Circular No. 12, s. 2022, on the 2022 Guidelines and Standards in the Establishment of Organizational Structures and Staffing Patterns in Local Government Units;
- 6. The Utilization of the Appropriation for Other Professional Services and Other General Services in the amount of Seven Hundred Forty Three Thousand Nine Hundred Twenty Five Pesos (P743,925.00) and Two Million Five Hundred Forty Five Thousand Pesos (P2,545,000.00) respectively, shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, on the Description of Accounts under the Revised Chart of Accounts for Local Government Units;

That the appropriation for Honoraria in the amount of Three Hundred Twenty Thousand Pesos (P320,000.00) shall be in accordance with DBM Local Budget Circular No. 62 dated July 29, 1996, on the Guidelines on the Grant of Honoraria in the Local Government Units (LGUs); DBM Budget Circular No. 2003-5 dated September 26, 2003, Prescribing Guidelines on the Grant of Honoraria of Government Personnel FY 2003 and onwards; DBM Budget Circular No. 2007-2 dated October 1, 2007, Guidelines of Honoraria Due to Assignment in Government Special Projects;
- 8. The utilization of 5% LDRRMF shall be in accordance with the approved Local Disaster Risk Reduction and Management Plan pursuant to RA 10121 and its implementing Rules and Regulations, as supplemented by NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013. Provided further, that the LDRRMF Plan shall be reviewed by the Office of Civil Defense (OCD) pursuant to RA 10121 and its implementing Rules and Regulations as supplemented by Local Budget Memorandum No. 85 dated June 15, 2022 and finalized by Local Budget Memorandum No. 85-B dated December 23, 2022, copy furnish the Office of the Sangguniang Panlalawigan of the reviewed LDRRMF;
- The appropriation for the 20% Development Fund shall strictly cover only the development projects prescribed and authorized under DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020.

That the following appropriations under the 20% Development Fund shall be identified or broken-down into specific/project component indicating the activities/programs to be undertaken and the project site/location in accordance with DILG-NEDA-DBM and DOF JMC No. 1 Series of 2007:

- Construction of Comfort Rooms (Seaprate M/F) with Water System for P450,000.00
- 2. Construction of Toothbrushing Area with Water System for P120,000.00
- 3. Construction of Comfort Rooms (Seaprate M/F) and Toothbrushing Area with Water System for P500,00.00
- 4. Construction of Washing Area for P100,000.00
- 5. Slope Protection in Various Barangays for P8,000,000.00
- 6. Construction of Sanitary Landfill Fence for P800,000.00
- 7. Construction of Monitoring Well to Determine Impact of Waste Disposal on Quality of Groundwater for P100,000.00
- 8. Construction of Gate with Signage for P500,000.00

- 10. Installation of Solar submersible Pump and Solar Lights for P350,000.00
- 10. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations;

RESOLVED FURTHER, to require the Municipality of San Mariano, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to furnish the Municipality of San Mariano, Isabela that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable EDGAR T. GO**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of San Mariano, Isabela through the **Honorable DEAN ANTHONY G. DOMALANTA**, Municipal Vice-Mayor.
