WHEREAS, Appropriation Ordinance No. 2022-1300, an ordinance authorizing Supplemental Budget No. 08 for Calendar Year 2022 of the Local Government of San Mariano, Isabela, amounting to FIVE HUNDRED SEVENTY NINE THOUSAND ONE HUNDRED PESOS (P579,100.00) derived from savings from some appropriations under some activities within the Local Council for the Protection of Children (LCPC) Plan and Senior Citizens & Persons With Disability for CY 2022 to cover various expenditures of the LCPC and Senior Citizens & PWDs through the Municipal Social Welfare & Development Office of the Municipality of San Mariano, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2022-1300 of the Municipality of San Mariano, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

- 1. That the utilization of the amount of Eighty Four Thousand One Hundred Pesos (P84,100.00) must be governed by Sec. 15 RA 9344, which states:
 - "One percent (1%) of the Internal Revenue Allotment of barangays, municipalities and cities shall be allocated for the strengthening and implementation of the programs, projects and activities of the LCPC provided, such allocation shall be disbursed in accordance with the AWFP endorsed by the LCPC to the local Sanggunian."
- That the utilization of the appropriation for PPAs for Senior Citizens and Persons with Disabilities in the amount of Four Hundred Ninety Five Thousand (P495,000.00) must be governed by RA No. 9994 The Expanded Senior Citizens Act of 2010 amending RA No. 7432 and RA No. 9442 The Magna Carta for Disabled Persons amending RA No. 7277;
- 3. That a PPA in the amount of Ten Thousand Pesos (P10,000.00) in Section 2 of the Ordinance must reconcile with the PPA amounting to One Hundred Seven Thousand Pesos (P107,000.00) in the LBP Form No. 9;
- 4. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations;

RESOLVED FURTHER, to require the Municipality of San Mariano, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of San Mariano, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
