**NOW THEREFORE**, on motion of SP Member **DELFINITO EMMANUEL L. ALBANO** duly seconded:

#### THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 2023-005 of the Municipality of Naguilian, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

- The creation of position shall be in consistent with the rules and regulations as prescribed under CSC Memorandum Circular No. 12, series of 2022. Further, creation of non-mandatory positions and offices in LGUs may be allowed subject to the following conditions:
  - a. They are the priority needs as identified by the LCE, the Sanggunian and/or LDCs concerned consistent with Section 17 of RA No. 7160;
  - b. All mandatory positions stipulated under RA No. 7160 have been created and provided;
  - c. The SSL has been fully implemented; and
  - d. The general limitations on PS Expenditures are not exceeded;
  - e. The classification of the position is consistent with the standards and implementing rules and regulations of RA No. 6758
- The appropriate nomenclature position title for the created position under Ordinance No. 2023-010 shall be *Labor and Employment* Officer III not Labor Employment Officer III as per LBC No. 137 dated July 13, 2021.
- 3. The utilization of Terminal Leave Benefits in the amount of Ninety Four Thousand Seven Hundred Twenty one and 79/100 (P94,721.79) shall be in accordance with DBM Budget Circular No. 2016-2 dated March 29, 2016 on the Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, and CSC Memorandum Circular No. 02 s. 2016, on Amendment to the Constant Factor in the Formula Used for Computing Terminal Leave Benefits (Section 40) and Computation of Leave Monetization (Section 24) of the Omnibus Rules on Leave;
- 4. The appropriation for the following account should be properly classified to specific Object of Expenditures and Account Code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:
