A RESOLUTION EXPRESSING FULL SUPPORT AND ADOPTION OF EXECUTIVE ORDER NO. 41, SERIES OF 2023, DULY ISSUED BY THE OFFICE OF THE PRESIDENT OF THE PHILIPPINES, PROHIBITING THE COLLECTION OF PASS-THROUGH FEES ON NATIONAL ROADS AND COLLECTION OF ANY FORM OF FEES UPON ALL TYPES OF VEHICLES TRANSPORTING GOODS

WHEREAS, Article X of the Philippine Constitution empowered the President to exercise general supervision over local government units (LGUs) and grants LGUs the power to create their own sources of revenue, levy government taxes, fees or charges subject to the guidelines and limitations as the Congress may provide;

WHEREAS, despite the authority of the LGU to fix the rates and prescribe the terms and conditions for the imposition of toll fees or charges in using any public road, Section 133 (e) of R.A. No. 7160 limits its taxing power by proscribing the imposition of

taxes, fees and charges and other imposition upon goods carried into or out of, or passing through its territorial jurisdiction;

WHEREAS, in order to uphold the welfare and advance the best interest of the Filipino people, the Office of the President of the Philippines issued Executive Order No. 41, Series of 2023, "Prohibiting the Collection of Pass-through Fees on National Roads and Urging Local Government Units to Suspend the Collection of any Form of Fees upon all Types of Vehicles Transporting Goods under Section 153 or 155 of Republic Act No. 7160 of the Local Government Code of 1991";

WHEREAS, this August Body is cognizant of the importance of supporting national policies in order to achieve national development goals and facilitate the speedy transportation and reduction of goods and services to our co-Isabeleños;

WHEREAS, in compliance with the mandates of the national government, the Provincial Government of Isabela, thru this August Body, fully support the President's goal of bringing down the commodity prices to ease the burden of Isabeleño consumers by prohibiting the collection of pass-through fees on national roads and suspend the collection of any form of fees upon all types of vehicles transporting goods by adopting Executive Order No. 41, S. 2023;

WHEREFORE, upon motion of Honorable Victor G. Dy, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION EXPRESSING FULL SUPPORT AND ADOPTION OF EXECUTIVE ORDER NO. 41, SERIES OF 2023, DULY ISSUED BY THE OFFICE OF THE PRESIDENT OF THE PHILIPPINES, PROHIBITING THE COLLECTION OF PASS-THROUGH FEES ON NATIONAL ROADS AND COLLECTION OF ANY FORM OF FEES UPON ALL TYPES OF VEHICLES TRANSPORTING GOODS.
