- 5. Reiterating our review action on your 2020, 2021 and 2022 Annual Budget that the Municipal General Services Office (MGSO) must be headed by a Department Head pursuant to the Civil Service Commission Memorandum Circular No. 12, s. 2022, on the 2022 Guidelines and Standards in the Establishment of Organizational Structures and Staffing Patterns in Local Government Units;
- Reiterating that the Position of Dentist III with SG-20/5 under the Office of the Municipal Health Officer when becomes vacant shall be downgraded to Dentist II SG-17/1 to conform with the guidelines of Local Budget Circular No. 53;
- 7. That the appropriation for **Donations** under the Local Disaster Risk Reduction Management Fund in the amount of One Million Pesos (P1,000,000.00) shall be classified according to its specific Programs, Projects & Activities (PPAs);
