THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 03 S. 2022 of the Municipality of Maconacon, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- The appropriation for the grant of Service Recognition Incentive (SRI) in the amount of Two Million Two Hundred Forty Thousand Pesos (P2,240,000.00) shall be in accordance with DBM Budget Circular No. 2022-4, dated December 20, 2022, on the Guidelines on the Grant of Service Recognition Incentive to Government Employees for Fiscal Year (FY) 2022;
- The Grant of Rice Assistance in the amount of Three Hundred Twenty Eight Thousand Pesos (P328,000.00) shall be in accordance with Administrative Order No. 02 dated December 16, 2022, Authorizing the One-time Grant of Rice Assistance to All Government Employees and Workers for Fiscal Year 2022;
- 3. The appropriation for the grant of Gratuity Pay to Contract of Service and Job Order Workers in the amount of One Million Eighty Thousand Pesos (P1,080,000.00) shall be in accordance with DBM Budget Circular No. 2022-5 dated December 28, 2022, on the Guidelines on the Grant of the Gratuity Pay to Contract of Service (COS) and Job Order (JO) Workers in Government for Fiscal Year 2022;
- 4. The appropriation for the following account should be properly classified to specific Object of Expenditures and Account Code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:
