A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T. ALBANO III, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, TO ENTER INTO A MEMORANDUM OF AGREEMENT AND DEED OF DONATION WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES-ENVIRONMENTAL MANAGEMENT BUREAU-REGION 02 (DENR-EMB-RO2) FOR THE DONATION OF ONE (1) UNIT 20-FOOTER CONTAINER VAN AND SIXTY THREE (63) UNITS OF 100L CAPACITY YELLOW BINS FOR THE COLLECTION OF COVID-19 RELATED HEALTHCARE WASTES

WHEREAS, under the Ecological Solid Waste Management Act of 2000, the State is mandated to secure proper segregation, collection, transport, storage, treatment and disposal of solid waste through the formulation and adoption of the best environmental practices in ecological waste management, excluding incineration;

WHEREAS, the Department of Environment and Natural Resources-Environmental Management Bureau in Region 02 (DENR-EMB-RO2) proposed to collaborate with the Provincial Government of Isabela (PGI) for its Project: "Brand-New Preliminary Disinfection and Storage Facilities for Collected COVID-19 related Wastes"

WHEREAS, the storage facility is designed to properly handle and control the disposal of infectious wastes and materials that could transmit illnesses;

WHEREAS, under the aforesaid project, DENR-EMB-RO2 commits to procure and donate one (1) unit of 20-footer Container Van and sixty-three (63) units of 100L capacity yellow bins to the Provincial Government of Isabela (PGI);

WHEREAS, DENR-EMB RO2 will provide support in the establishment of Preliminary Disinfection and Storage Facilities that will improve the collection of COVID-19 related healthcare waste from quarantine facilities, testing facilities, and vaccination sites located in remote areas, including small generators that are not serviced by a Transport, Storage, and Disposal Facility;

WHEREAS, PGI's acceptance for the aforesaid donation requires the execution of a Memorandum of Agreement and Deed of Donation between the PGI and the Department of Environment and Natural Resources — Environmental Management Bureau- Region 02 (DENR-EMB — RO2);

WHEREAS, under Section 465, (b) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement and Deed of Donation on behalf of the Provincial Government of Isabela;

NOW THEREFORE, premises considered, upon motion of the Honorable Marco Paolo A. Meris, duly approved and seconded in a session duly assembled, it was –
