WHEREAS, the rapid urban growth and population expansion in Isabela present significant challenges for solid waste management;

WHEREAS, the DENR-EMB has initiated a project to assist LGUs in their solid waste management efforts;

WHEREAS, recognizing the immediate need for effective solid waste management amid rapid urban growth, the Provincial Government of Isabela expressed interest in participating in the project and the DENR-EMB agreed to provide Ecological Solid Waste Management Equipment (Plastic Molder) to support these efforts;

WHEREAS, for the formalization of this partnership and to define their respective roles for the said project, the Provincial Government of Isabela and the DENR-EMB Central Office must enter into a Memorandum of Agreement (MOA);

WHEREAS, presented for the review and approval of this August Body is the proposed MOA between the Provincial Government of Isabela and DENR-EMB Central Office for the institutionalization of their partnership for the said project which includes the former's receipt of an Ecological Solid Waste Management Equipment (Plastic Molder) from the latter;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after careful review, this August Body determined the said proposed MOA to be just and lawful and that granting the Honorable Governor the authority to sign such document on behalf of the Provincial Government of Isabela to be beneficial to the Isabeleños;

**WHEREFORE**, upon motion of the Honorable Marco Paolo A. Meris, duly approved and seconded in a session duly assembled, it was –
