WHEREAS, Ordinance No. 2023-516, an Ordinance approving Supplemental Budget No. 01 for Fiscal Year 2023 in the amount of TWELVE MILLION FORTY EIGHT THOUSAND FOUR HUNDRED SIXTEEN PESOS & 60/100 (P12,048,416.60) derived from the savings from the share of the City of Cauayan, Isabela on the collection of Burley and Native Tobacco Excise Tax for Calendar Years 2015, 2016, 2017, 2018 and 2019 for the implementation of various PPAs of the City Government of Cauayan, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

A RESOLUTION DECLARING ORDINANCE NO. 2023-516 (SUPPLEMENTAL BUDGET NO. 01 FY 2023) IN THE AMOUNT OF TWELVE MILLION FORTY EIGHT THOUSAND FOUR HUNDRED SIXTEEN PESOS & 60/100 (P12,048,416.60) OF THE CITY OF CAUAYAN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160.

NOW THEREFORE, on motion of SP Member **DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2023-516 of the City of Cauayan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- 1. The utilization of the reprogrammed project to be funded from the Local Government share in the Burley and Native Tobacco Excise Tax for the Fiscal Year 2015 amounting to One Hundred Ninety One Thousand Nine Hundred Pesos (P191,900.00) shall adhere with the provisions of LBM No. 76, dated October 6, 2017 on the Guidelines on the release and utilization of the shares of LGUs from the collections of Excise Tax on locally manufactured Virginia-type cigarettes under Republic Act No. 7171, and Burley and Native Tobacco Excise Tax pursuant to RA No. 8240, as amended by RA No. 10351, chargeable against the allocations to LGUs under the FY 2016 General Appropriations Act (GAA), Republic Act No. 10717, Continuing Appropriations, and FY 2017 GAA, RA No. 10924;
- 2. The utilization of the reprogrammed project to be funded from the Local Government share in the Burley and Native Tobacco Excise Tax for the Fiscal Year 2016 amounting to Five Hundred Twenty Four Thousand Five Hundred Eighteen Pesos (P524,518.00) shall adhere with the provisions of LBM No. 79, dated June 14, 2019 on the Guidelines on the release and utilization of the shares of LGUs from the FY 2016 collections of Excise Tax on locally manufactured Virginia-type cigarettes under Republic Act No. 7171, and Burley and Native Tobacco Excise Tax pursuant to RA No. 8240, as amended by RA No. 10351, chargeable against the allocations to LGUs under the FY 2018 General Appropriations Act (GAA), Republic Act No. 10964, Continuing Appropriations;
- 3. The utilization of the reprogrammed project to be funded from the Local Government share in the Burley and Native Tobacco Excise Tax for the Fiscal Year 2017 amounting to Seventy Nine Thousand Three Hundred Thirty Five Pesos & 50/100 (P79,335.50) shall adhere with the provisions of LBM No. 81, dated November 4, 2020 on the Guidelines on the release and utilization of the shares of LGUs from the FY 2017 collections of Excise Tax on locally manufactured Virginia-type cigarettes under Republic Act No. 7171, and Burley and Native Tobacco Excise Tax pursuant to RA No. 8240, as amended by RA No. 10351, chargeable against the allocations to LGUs under the FY 2019 General Appropriations Act (GAA), Republic Act No. 11260;

- 4. The utilization of the reprogrammed projects to be funded from the Local Government share in the Burley and Native Tobacco Excise Tax for the Fiscal Year 2018 amounting to Thirty Three Thousand Seven Hundred Ninety Pesos & 50/100 (P33,790.50) shall adhere with the provisions of LBM No. 83, dated November 22, 2021 on the Guidelines on the release and utilization of the shares of LGUs from the FY 2018 collections of Excise Tax on locally manufactured Virginia-type cigarettes under Republic Act No. 7171, and Burley and Native Tobacco Excise Tax pursuant to RA No. 8240, as amended by RA No. 10351, chargeable against the allocations to LGUs under the FY 2020 General Appropriations Act (GAA), Republic Act No. 11465;
- 5. The utilization of the reprogrammed projects to be funded from the Local Government share in the Burley and Native Tobacco Excise Tax for the Fiscal Year 2019 amounting to Eleven Million Two Hundred Eighteen Thousand Eight Hundred Seventy Two Pesos & 60/100 (P11,218,872.60) shall adhere with the provisions of LBM No. 84, dated November 22, 2021 the Guidelines on the release and utilization of the shares of Local Government Units (LGUs) from the FY 2019 collections of Excise Tax on Locally Manufactured Virginia-type Cigarettes under Republic Act No. 7171, and Burley and Native Tobacco Excise Tax pursuant to RA No. 8240, as amended by RA No. 10351, chargeable against the allocations to LGUs (ALGU) and Unprogrammed Appropriations (UA) under the FY 2021 General Appropriations Act (GAA), Republic Act No. 11518;
- 6. The project *Procurement of Agricultural Drone* in the amount of One Million Five Hundred Thousand Pesos (P1,500,000.00) is not included in the menu/projects to be funded from the LGU share from Burley and Native Tobacco Excise Tax (LBM No. 84). However, the said project shall be replaced or substituted with another project that is compliant with Item No. 2.3.1 of LBM No. 84;
- 7. The appropriation for the following accounts should be properly classified to specific Object of Expenditure and Account Code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:

8. The proposed projects shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

RESOLVED FURTHERMORE, to inform the City of Cauayan, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
