WHEREAS, Ordinance No. 2023-027, an Ordinance authorizing Supplemental Budget No. 04 Calendar Year 2023 involving an amount of TWO MILLION THREE HUNDRED SEVENTY THREE THOUSAND TWO HUNDRED THIRTY EIGHT PESOS AND 30/100 (P2,373,238.30) derived from the savings of Personal Services for the creation of the positions of One (1) License Inspector II, Two (2) Revenue Collection Clerk II, and One (1) Accountant II and various expenditures of the Municipal Government of Jones, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

**NOW THEREFORE**, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

### THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Ordinance No. 2023-027 of the Municipality of Jones, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- 1. The creation of positions shall be consistent with the rules and regulations as prescribed under CSC Memorandum Circular No. 12, series of 2022. Further, creation of non-mandatory positions and offices in LGUs may be allowed subject to the following conditions:
  - a. That they are the priority needs as identified by the LCE, the Sanggunian and/or LDCs concerned consistent with Section 17 of RA No. 7160;
  - b. All mandatory positions stipulated under RA No. 7160 and other pertinent laws have been created and provided;
  - c. The SSL has been fully implemented;
  - d. The general limitations on PS expenditures are not exceeded;
  - e. The classification of the positions is consistent with the standards and implementing rules and regulations of RA No. 6758;
- 2. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

**RESOLVED FURTHER**, to require the Municipality of Jones, Isabela to comply with the herein conditions.

**RESOLVED FURTHERMORE**, to inform the Municipality of Jones, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable NHEL C. MONTANO**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Jones, Isabela through the **Honorable EVELYN R. RASPADO**, Municipal Vice Mayor.
