ALBANO III TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH — CENTER FOR HEALTH DEVELOPMENT (DOH-CHD) CAGAYAN VALLEY — CENTER FOR HEALTH DEVELOPMENT FOR THE INTEGRATION AND IMPLEMENTATION OF THE INTEGRATED HOSPITAL OPERATIONS AND MANAGEMENT INFORMATION SYSTEM IN THE GOVERNOR FAUSTINO N. DY SR. MEMORIAL HOSPITAL

WHEREAS, the Provincial Government of Isabela recognizes the benefits of digitalization on the improvement of government services, especially in facilitating government transactions and making government records more secure and accessible to the people;

WHEREAS, the Department of Health (DOH) developed a software which it dubbed as Integrated Hospital Operations and Management Information System (iHOMIS). This software is a reference model for electronic medical records and hospital information that satisfies the Philippine Health Insurance Corporation requirements for electronic claims;

WHEREAS, the iHOMIS software is provided for free to interested public hospitals, including the training and technical support, subject to compliance of the DOH for hospital operations, acceptability of ICT infrastructure in place, and commitment for hospital management and operation support including availability of at least two (2) iHOMIS system administrators;

WHEREAS, the Provincial Government of Isabela has signified its interest on the integration and implementation of the iHOMIS in the Governor Faustino N. Dy Sr. Memorial Hospital, a hospital which it owns and operates;

WHEREAS, submitted for the review and approval of this August Body is a Memorandum of Agreement (MOA), to be entered between the Provincial Government of Isabela and the DOH-CHD Cagayan Valley – Center for Health Development, for the integration and implementation of the iHOMIS in the Governor Faustino N. Dy Sr. Memorial Hospital;

WHEREAS, after careful review of the said MOA, this August Body determined that the same is just, lawful, and will result to the improvement of the record and information management system of the Governor Faustino N. Dy Sr. Memorial Hospital. Furthermore, this August Body determined that granting the Honorable Governor the authority to sign such MOA on behalf of the Provincial Government of Isabela to be beneficial to and will advance the welfare of the Isabeleños;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, upon motion of the Honorable Ramon Juan N. Reyes Jr., duly approved and seconded in a session duly assembled, it was –
