the agriculture sector in the formulation of its policies and in the implementation of its programs;

WHEREAS, the Provincial Government of Isabela recognizes cooperatives as key partners in the attainment of genuine, lasting, and inclusive progress in the province;

WHEREAS, in line with such policies, the Provincial Government of Isabela has identified and endorsed the construction of a warehouse with solar dryer at Alinam, City of Ilagan, Isabela as its priority subproject for the DA's PRDP, which was approved by the Regional Project Advisory Board;

WHEREAS, on April 27, 2017, the Provincial Government of Isabela and the DA entered into an Implementation Management Agreement (Infrastructure Development) which set out their respective commitments and obligations for the implementation of the abovementioned subproject;

WHEREAS, by reason thereof, the Provincial Government of Isabela has procured the necessary civil works in accordance with the Operations Manual and Procurement Guidelines of the PRDP;

WHEREAS, this particular I-BUILD subproject is already completed and is now ready for turn-over and acceptance to the Subproject recipient;

WHEREAS, Article VII, Section 7.06 of the Implementation Management Agreement (IMA) states that "upon the issuance of the Certificate of Completion, the PLGU shall operate and maintain, or cause to be operated and maintained properly, the structures, systems and facilities constructed, installed or established under the subproject and shall pass an appropriation ordinance providing for the funds, facilities, services, and other resources required for the purpose for the next ten (10) years after subproject completion."

WHEREAS, in line with the pro-cooperative and agriculture development policies of the Provincial Government of Isabela, it tapped the Isabela Seed Growers Multi-Purpose Cooperative, whose qualifications, organizational capability, and reliability were duly assessed, to operate and maintain the subproject for and on behalf of the Provincial Government of Isabela;

WHEREAS, submitted for the review and approval of this August Body is the Memorandum of Agreement (MOA), to be entered into between the Provincial Government of Isabela and the Isabela Seed Growers Multi-Purpose Cooperative, concerning the donation of the said subproject and providing the responsibilities of both parties;

WHEREAS, after careful review of the said MOA, this August Body determined that such is just, lawful, and provides the necessary safeguards to ensure compliance, proper maintenance and operation of the subproject, and accountability on the part of
