WHEREAS, the Provincial Government recognizes the potential socio-economic impact of fostering relationships between educational institutions and enterprises, particularly in the context of advancing TVET programs to meet the evolving demands of the workforce;

WHEREAS, a promising opportunity has opened for collaboration between Milagros Albano District Hospital as Partner Enterprise of STTIS in providing support to the TVI SIL of its TVET learners:

WHEREAS, the collaboration with STTIS not only enhances the TVI SIL but also exemplifies the Provincial Government's commitment to innovation, excellence, and the seamless integration of academic knowledge with practical skills;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after a careful review, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;
