WHEREAS, the Provincial Government of Isabela recognizes the importance of documenting and safeguarding the cultural wealth for future generations which ensures the continuity and sustainability of Isabela's cultural legacy;

WHEREAS, Section 14(b) of Republic Act No. 10066 or the National Heritage Act of 2009 requires local government units to establish and maintain a registry for their local cultural property;

WHEREAS, to ensure the LGUs' compliance with such a legal directive, the National Commission on Culture and Arts (NCCA) and the Department of the Interior and Local Government (DILG) jointly issued Joint Memorandum Circular No. 2018-01, which enjoined all LGUs to establish and maintain a local inventory of cultural property that shall form part of the Philippine Registry of Cultural Property;
