A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR RODOLFO T. ALBANO III TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) A DEED OF USUFRUCT WITH THE ISABELA II ELECTRIC COOPERATIVE INVOLVING A PARCEL OF LAND OWNED BY THE PGI MEASURING TWELVE THOUSAND SIX HUNDRED FORTY FOUR (12,644) SQUARE METERS, MORE OR LESS, LOCATED IN BARANGAY ALIBAGU, CITY OF ILAGAN, ISABELA COVERED BY ORIGINAL CERTIFICATE OF TITLE NO. 2020000129 (SPECIAL PATENT NO. SP-LGU-ISA-0052)

WHEREAS, the Provincial Government of Isabela recognizes the Isabela II Electric Cooperative (ISELCO II), a non-stock, non-profit electric cooperative duly registered with the National Electrification Administration and the Cooperative Development Authority, as an indispensable partner in providing reliable electric power services in Isabela which contributes to the attainment of inclusive economic growth;

WHEREAS, ISELCO II, in pursuit of service improvement, seeks to occupy a 12,644 square meter portion of the Provincial Government of Isabela's property located in Alibagu, City of Ilagan, Isabela that is covered by Original Certificate of Title No. 2020000129. If approved, ISELCO II commits to introduce structures, equipments, or any other improvements therein that will result to a wider and more reliable electric power services to their member-consumer-owners, ultimately redounding to the benefit of the Isabeleños:

WHEREAS, the Office of the Governor has expressed its support to such endeavor of ISELCO II and demonstrated its desire to enter into a Deed of Usufruct with ISELCO II on behalf of the Provincial Government of Isabela that will grant ISELCO II with usufructuary rights over such portion of the aforesaid property;

WHEREAS, submitted for the review of this August Body is the proposed Deed of Usufruct to be entered into by the Provincial Government of Isabela and ISELCO II which will grant to the latter usufructuary rights over a 12,644 square meter portion, more or less, of the property of the former located in Alibagu, City of Ilagan, Isabela covered by Original Certificate of Title No. 202000129 (Special Patent No. SP-LGU-ISA-0052) issued by the Registry of Deed for the Province of Isabela;

WHEREAS, as provided in the Deed of Usufruct, such portion is more particularly described and bounded as follows:

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, upon motion of the Honorable Edward S. Isidro, duly approved and seconded in a session duly assembled, it was –
