WHEREAS, HCPNs may be composed of integrated local health systems, such as the province-wide health systems, and networks of private health care providers to complement the health services provided by public health facilities, or mixed publicprivate networks of health service providers;

WHEREAS, the Department of Health (DOH) requires for the identification of apex or end-referral hospitals that may be contracted as stand-alone facilities by PhilHealth:

WHEREAS, the Department of Health — Drug Abuse Treatment and Rehabilitation Center (DOH-DATRC) - Region 02 has been designated by the DOH as a specialty hospital that will provide specialized services needed by its catchment population;

**WHEREAS**, the Provincial Government of Isabela, thru its Province-Wide Health System, is required to contract apex or end-referral hospitals that will function as standalone facilities by PhilHealth;

WHEREAS, the DOH-DATRC has expressed its willingness and ability to become an apex or end-referral hospital, as PGI's specialty hospital;

**WHEREAS**, the execution of a Memorandum of Agreement between the PGI, the DOH-DATRC (Region 2) is required;

WHEREAS, under Section 465, (b) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREFORE, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T.
