WHEREAS, City Appropriation Ordinance No. 02-2021, an ordinance authorizing the Annual General Fund Budget of the City Government of Ilagan for Fiscal Year 2022 in the amount of TWO BILLION SEVEN HUNDRED EIGHTY EIGHT MILLION SEVEN HUNDRED FORTY TWO THOUSAND FIVE HUNDRED THIRTY PESOS & 91/100 (P2,788,742,530.91) and the operation of Economic Enterprise in the amount of ONE HUNDRED ONE MILLION TWO HUNDRED FIFTY SEVEN THOUSAND FOUR HUNDRED SIXTY NINE PESOS & 09/100 (P101,257,469.09) covering the various expenditures for the operation of the City Government of Ilagan for Fiscal Year 2022 and appropriating the necessary funds for the purpose, was submitted to this Sanggunian for review, pursuant to the provision of Section 327 of Republic Act 7160, otherwise known as the Local Government Code of 1991.

3. Reiterating our review action on your 2021 Annual Budget that the position of Attorney IV, SG-23 under the City Legal Office is not in accordance with Section 4(d) of Local Budget Circular No. 53, which states that:

"The highest level of Position below the Assistant Department Head shall be limited to the allocated Salary Grade for Component Cities, which is Salary Grade 22"

Since the subject position does not conform to the herein prescribed allowable SG allocation, correction shall be effected without diminution in salary of the concerned personnel. However, *subsequent salary increase shall be applied only on the correct classified position*.

- 4. Reiterating that the positions under the **City of Ilagan Medical Center** (**CIMC**) shall be in accordance with DBM-DOH Joint Circular No. 2013-1 dated September 23, 2013, on the Revised Standards on Organizational Structure and Staffing Pattern of Government Hospitals, CY 2013 Edition;
- 5. Reiterating our review action on your 2021 Annual Budget that the position of Chief of Hospital III with SG-26 at the City of Ilagan Medical Center (CIMC) is not allowed for a Level I Hospital as per DBM-DOH Joint Circular No. 2013-1 dated September 23, 2013, on the Revised Standards on Organizational Structure and Staffing Pattern of Government Hospitals, CY 2013 Edition, hence, disallowed. The said position shall be downgraded in accordance with the said guidelines.
- 6. Reiterating our review action on your 2021 Annual Budget that the following created positions under the City of Ilagan Medical Center (CIMC) **shall not be allowed** pursuant to Sec. 4 (d) of LBC No. 53 of which the highest level of position below Assistant Department Head for Component Cities shall be limited to **SG-22**:

Since the subject positions do not conform to the herein prescribed allowable SG allocation, correction shall be effected without diminution in salary of the concerned personnel. However, *subsequent salary increase shall be applied only on the correct classified position*. Vacant item Nos. 25.25 and 25.35 are hereby recommended to be *downgraded*.

7. Reiterating our review action on your 2021 Annual Budget that the vacant position of Dentist IV SG-23 as reflected in the duly approved Plantilla under the City Health office - RHU I shall be downgraded and the position of Dentist IV SG-23 with incumbent as reflected under the duly approved Personnel Schedule under the City Health office - RHU II, once vacated, shall be corrected to conform to the provisions of Item No. 9.2.1.5 of the Manual on Position Classification and Compensation Scheme (MPCCS) in LGUs under Circular Letter No. 2007-6 dated February 19, 2007, as implemented by Local Budget Circular No. 53 dated September 1, 1993, quoted below:

"Item 9.2.1.5 – highest positions below the Assistant Department Head shall be limited to **SG 22** for Component Cities."

Since the subject position does not conform to the herein prescribed allowable SG allocation, correction shall be effected without diminution in salary of the concerned personnel. However, *subsequent salary increase shall be applied only on the correct classified position;*

- 8. Reiterating our review action on your 2021 Annual Budget that there should only be one City Government Department Head (Chief of Hospital) in one office. The position of Chief of Hospital II with SG-25 at the San Antonio Hospital is not within the list of the Tally of Positions for Level I Hospital as per DBM-DOH Joint Circular No. 2013-1 dated September 23, 2013, on the Revised Standards on Organizational Structure and Staffing Pattern of Government Hospitals, CY 2013 Edition, hence, disallowed. Since the position is vacant, it is hereby recommended to be abolished or to be downgraded to a level of position applicable to a Level I hospital;
- Reiterating our review action on your 2021 Annual Budget that the Operations of Market & Slaughterhouse must be headed by a Department Head pursuant to Civil Service Commission Memorandum Circular No. 19, s. 1992, on the Guidelines and Standards in the Establishment of Organizational Structures and Staffing Patterns in Local Government Units;
- 10. The appropriation for Overtime and Night Pay in the amount of Eight Million One Hundred Thousand Pesos (P8,100,000.00) shall be in accordance with the guidelines of CSC-DBM Joint Circular No. 1, series 2015 dated November 25, 2015, on the Policies and Guidelines on Overtime Services and Overtime Pay for Government Employees;
- 11. The appropriation for Consultancy Services and Other General Services in the amount of Three Million Pesos (P3,000,000.00) and Two Hundred Twenty One Million Eight Hundred Sixty Thousand Five Hundred Thirty Two Pesos & 16/100 (P221,860,532.16) respectively, must be governed by the provisions of Republic Act 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations;

The utilization of the appropriation for the 20% Development Fund shall be in accordance with DILG-NEDA-DBM and DOF JMC No. 1 Series of 2007 and shall strictly cover only the development projects prescribed and authorized under DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020;
 - 19. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations. Further, the acquisition of Motor Vehicles in the amount of Ninety Four Million Seven Hundred Seventy Five Thousand Pesos (P94,775,000.00) shall be subject to the provisions of Budget Circular No. 2019-3 dated May 16, 2019 and Administrative Order No. 14 dated December 10, 2019;

RESOLVED FURTHER, to require the City of Ilagan, Isabela to comply with the herein review findings/conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the City of Ilagan, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting rules and regulations.
